**Right to erasure/ Right to be forgotten\***

Following your request, d'Haudrecy Art Gallery will erase your personal data without undue delay where one of the following grounds applies:

- Your personal data are no longer necessary in relation to the purposes for which they were collected or otherwise processed
- You have withdrawn your consent with regards to the processing and there exists no other legal ground for the processing
- You object to the processing and there are no overriding legitimate grounds for the processing or you object to the processing for direct marketing purposes
- Your personal data have been unlawfully processed
- Your personal data have to be erased for compliance with a legal obligation which exists on the part of d'Haudrecy Art Gallery
- Your personal data have been collected in relation to the offer of information society services

**Right to restriction of processing\***

You wish d'Haudrecy Art Gallery to limit the processing of your personal data and one of the following grounds applies:

- You contest the accuracy of your personal data. Your personal data will not be processed for the period enabling d'Haudrecy Art Gallery to verify the accuracy
- The processing is unlawful and you oppose the erasure of your personal data and request a restriction of the use of your personal data instead
- d'Haudrecy Art Gallery no longer needs your personal data for the purposes of the processing but you require them for the establishment, exercise or defence of legal claims

**Note:** d’Haudrecy Art Gallery shall no longer process your personal data unless d’Haudrecy Art Gallery demonstrates compelling legitimate grounds for the processing which override your interests, rights and freedoms or for the establishment, exercise or defence of legal claims

**III. REACTION OF d’HAUDRECY ART GALLERY TO YOUR REQUEST**

d’Haudrecy Art Gallery shall provide without undue delay and in any event within one month of receipt of your request, information on action taken on your request.

Depending on the complexity of your request and the number of requests, that period may be extended by two further months where necessary. In that case, d’Haudrecy Art Gallery will inform you within one month of receipt of your request.

If d’Haudrecy Art Gallery does not take action on your request, d’Haudrecy Art Gallery will inform you within one month of receipt of your request and, in addition, d’Haudrecy Art Gallery will provide the reasons for not taking action on your request. d’Haudrecy Art Gallery will also inform you on the options to (i) lodge a complaint with a supervisory authority or (ii) seek a judicial remedy.

**IV. PROOF OF YOUR IDENTITY**
